LIABILITY

The Art Association will insure all works accepted in to the exhibition only for the duration of the exhibit (May 2017 to June 2017). Entries will be insured for two-thirds the listed sale price with a net maximum of \$1000 per item. Shipping insurance for works accepted into this exhibition must be arranged by the artist. The Art Association will not be responsible for any loss or damage to artwork before its delivery or after its pick-up from the Art Association building. The Art Association will not be responsible for minor scratches or dents to frames, breakage of glass, or scratches to Plexiglas incurred during the run of the show.

SALES

In the event of sale, the Art Association is considered sole agent during this exhibit, and will receive a donation of 33 1/3 percent of the sale price. The same percentage is expected on all sales for orders taken for additional prints during the show. Payment to the artist will be made no longer than 30 days after the close of the exhibition. No works marked "POR" (Price on Request) will be accepted. However, works marked "Private Collection" may be entered.

FEES

The non-refundable fee is \$15.00 per entry for non-members, (AAH members pay \$12.50 per entry). Artists may submit up to two entries. Sculptors may submit two different views of a work, if desired. Make checks payable to the Art Association of Harrisburg.

ENTRIES

Entries may be submitted as high-resolution (at least 300 dpi) JPEG images on CD or electronically by following the steps on our website at www.artassocofhbg.com under the Juried Show Entries button. (CDs of accepted entries become the property of AAH.) Include a self-addressed, stamped envelope if you wish to have CDs not included in the exhibit returned.

SUBMISSION DEADLINE

All entries must be postmarked or received by no later than February 28, 2017. Notification of accepted or rejected works will be made by email.

ELIGIBLE WORKS

All original work in all media is eligible provided it has not been previously exhibited at the Art Association. Media categories for awards are Oil & Acrylic, Watercolor, Photography, Prints & Graphics, Sculpture & Ceramics and Other Media.

PRESENTATION

All watercolors, graphics, and photographs must be matted and framed under glass or Plexiglas. No uniframe or frames that leave the edges of glass exposed will be accepted. All oils and acrylics must be framed, or have the edges of the canvas neatly finished. All two-dimensional works must have screw eyes and wire in place, ready for hanging. Works without hanging hardware in place will not be hung. Wet paintings or frames will NOT be accepted. Unusual or experimental pieces may be accepted pending the approval of the exhibition and building committees. Maximum size of any entry in any direction must not exceed 72" (outside dimensions of frame).

DELIVERY AND RETURN OF ACCEPTED WORKS

Works may be hand-delivered OR shipped to the Art Association of Harrisburg, 21 N. Front St., Harrisburg, PA 17101 and must be received by May 7, 2017. Please note that we are no longer using G/B International Packing Service.

Accepted artists are responsible for insurance on shipped works and must include return postage or FedEx/UPS labels, along with reusable packing material.

Return dates for shipped works are June 19-23, 2017. Hand delivered art should be picked up at the close of the show from June 16-25, 2017.
